

Note on Expired UDP Policies

The UDP policies in the table below are deemed not to meet the provisions of Section 38 of the Planning and Compulsory Purchase Act and expired on 27th September 2007.

All other policies of Enfield's adopted UDP 1994 will remain valid until they are replaced by Enfield's new Local Development Framework (LDF).

Enfield's Supplementary Planning Guidance (SPG) will continue to exist as non-statutory guidance whilst relevant saved policies are in place.

The site proposals listed in the table to the right have been completed and therefore have been removed from the schedule in Appendix A3 and the Proposals Map.
