

OLD PARK ROAD N13 AND RADCLIFFE ROAD N21 - PLAY STREET ROAD CLOSURES

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Enfield have made the Enfield (Play Street Restrictions) (No.2) Order 2025 under section 29 to the Road Traffic Regulation Act 1984.
2. The effect of the Order will be to prohibit vehicles from entering or proceeding on the sections of Old Park Road N13, as specified in Schedule 1 to this notice on the dates detailed in Schedule 2 to this notice.
3. The Order provides that the prohibition will not apply to –
 - (a) any vehicle requiring access to a property in Old Park Road N13 and Radcliffe Road N21;
 - (b) any vehicle being used for police, fire brigade or ambulance purposes, or for the purposes of a statutory undertaker in an emergency; or
 - (c) anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a civil enforcement officer.
4. A copy of the Order, which will come into operation on the dates and times detailed in schedule 2 to this notice and any other relevant documents can be inspected at the Town Library, 66 Church Street, Enfield EN2 6AX, Monday to Fridays 9am – 5pm inclusive during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Order was made.

5. Any person desiring to question the validity of the Order or of provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulation made thereunder has not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.

Coming into operationsee Article 1

The Council of the London Borough of Enfield, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by section 29 of the Road Traffic Regulation Act 1984(a), and of all other powers thereunto enabling, hereby make the following Order:

1. This Order shall come into operation on the dates and times specified in the schedule to this order and may be cited as the Enfield (Play Street Restrictions) (No.2) Order 2025.
2. No person shall cause or permit any vehicle to enter or proceed in any street or part of a street specified in column 1 of Schedule 1 to this Order on the dates and times specified in Schedule 2 in relation thereto.
3. Nothing in Article 2 of this Order shall apply in relation to a vehicle -
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) being used in the service of a statutory undertaker in an emergency;
 - (c) needing to gain access to or leave any land or premises abutting thereon or accessible only therefrom;

4. Nothing in Article 2 of this Order shall apply to anything done with the permission or at the direction of a police constable in uniform or a civil enforcement officer.
