Guidance Notes:

Under the provisions of the above Act, no person may carry on the business of a hairdresser or barber on any premises in the London Borough of Enfield unless he or she is registered by the Council in respect of those premises under Section 21 of the Greater London Council (General Powers) Act, 1967. Failure to register could result, on conviction, in a fine not exceeding £200 and a daily fine not exceeding £5.

Application for registration should be made on this form which must be **emailed to licensing@enfield.gov.uk**. On receipt of an application the Council will issue to the applicant a certificate of registration and a copy of byelaws as to hairdressers and barbers which have been made under Section 77 of the Public Health Act, 1961 for the purpose of securing:-

- (a) the cleanliness of premises on which a hairdresser's or barber's business is carried on and of the instruments, towels, materials and equipment used therein, and
- (b) the cleanliness of the hairdressers or barbers working in such premises in regard to both themselves and their clothing.

Persons registered must keep a copy of the registration certificate and of the byelaws prominently displayed in their premises. Failure to comply with this provision carries a penalty on conviction of a fine not exceeding £50 and a daily fine not exceeding 50 pence.

- In the case of a limited company the full name of the company and the address of its registered office must be entered on the form.
- In the case of a partnership the full names and addresses of all the partners must be entered on the form.
- The form should be signed by the individual applicant, by all partners in the case of a partnership and by the Secretary in the case of a limited company.
