STATEMENT OF REASONS

CHANGES TO PERSONALISED DISABLED PERMIT PARKING PLACES AND DISABLED PERSONS PARKING PLACES IN VARIOUS ROADS THROUGHOUT THE BOROUGH

The personalised disabled person permit parking places are intended to address the need for a specific parking place for the disabled applicant that meets the Council's criteria which would not be met by the general use disabled bay. This is because a general use disabled bay is available for any motorist whose vehicle is carrying a disabled person and displays the disabled persons 'Blue' badge.

The revocation of personalised disabled person permit parking places and disabled person parking places are necessary as those parking places are no longer required.

Designation of parking places and application of the Order of 2017 thereto
