You may be eligible for the Terrific Two's funding entitlement if you are in receipt of the following:

Income Support
income-based Jobseeker's Allowance (JSA)
income-related Employment and Support Allowance (ESA)
Universal Credit, and your household income is £15,400 a year or less after tax, not including benefit payments
tax credits, and your household income is £16,190 a year or less before tax
the guaranteed element of Pension Credit
the Working Tax Credit 4-week run on (the payment you get when you stop qualifying for Working Tax Credit)
are looked after by a local authority
have a statement of special education needs (SEN) or an education, health and care (EHC) plan
get Disability Living Allowance
have left care under an adoption order, special guardianship order or a child arrangements order

### If you're a non-EEA citizen who cannot claim benefits

You may be eligible for the Terrific Two's funding entitlement if you are getting support under the Immigration and Asylum Act and have either:

claimed asylum in the UK and are waiting for a decision (known as 'part 6')
been refused asylum in the UK (known as 'section 4')
your household income is £15,400 a year or less after tax, and you have either:
leave to remain with 'no recourse to public funds' on family or private life grounds
the right to live in the UK because you're the main carer of a British citizen (known as a 'Zambrano Carer')
