

# Notice of Election

## Election of a Greater London Assembly Member for the Enfield and Haringey Constituency

- 1) If the election is contested, the poll will take place on **Thursday 2<sup>nd</sup> May 2024**.
- 2) Nomination forms for this election may be obtained from the Constituency Returning Officer at Enfield Civic Centre, Silver Street, Enfield, Middlesex, EN1 3XA.
- 3) Nomination papers must be delivered to the Constituency Returning Officer at Enfield Civic Centre, Silver Street, Enfield, Middlesex, EN1 3XA between the hours of 10:00am and 4:00pm on or after the date of this notice (excluding weekends and bank holidays), but not later than **4:00pm on Wednesday 27<sup>th</sup> March 2024**. On arrival report to the main business desk and ask for the Electoral Services Office.
- 4) Nomination papers must be accompanied by a deposit of £1,000. The deposit can be paid in one of the following ways:
  - In legal tender (cash);
  - By means of a banker's draft drawn on a bank operating in the UK, made payable to the 'London Borough of Enfield';
  - By the electronic transfer of funds\*. Details of the account to which payment is to be made are:

- 5) Applications to register to vote must reach the relevant Electoral Registration Officer by **midnight on Tuesday 16<sup>th</sup> April 2024**. Applications can be made online at **www.gov.uk/registertovote**.
- 6) Applications for new postal votes and for amendments to or cancellation of existing postal or proxy votes must be received by the relevant Electoral Registration Officer\*\* by **5:00pm on Wednesday 17<sup>th</sup> April 2024**. Applications can be made online at **www.gov.uk/apply-postal-vote**.
- 7) Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the relevant Electoral Registration Officer\*\* by 5pm on **Wednesday 24<sup>th</sup> April 2024**. Applications can be made online at **www.gov.uk/applyforphotonidtovote**.
- 8) New applications to vote by proxy must be received by the relevant Electoral Registration Officer\*\* by **5:00pm on Wednesday 24<sup>th</sup> April 2024**. Some applications can be made online at **www.gov.uk/apply-proxy-vote**.
- 9) Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer\*\* by **5:00pm on Thursday 2<sup>nd</sup> May 2024**.

\*Payment of deposits by electronic transfer will only be accepted where funds are cleared by **4:00pm on Wednesday 27<sup>th</sup> March 2024**.
