Application for a White Line Entrance Marking

Further to your recent request for the provision of a vehicle crossover white line entrance marking outside your property, please note this service is subject to the following conditions:

- You must have a parking area and an existing, legally constructed, vehicle crossover.
- The white line will be painted to the width of the vehicle crossover outside your property only and will not extend beyond it. Please note that where a crossover is joined to a neighbour's crossover (including shared driveways), you must allow proper vehicular access to your neighbour's property at all times.
- The cost of the white line is **£210** per property and is payable in advance. This fee is for the cost of administration and painting of the white line only. Once painted, the white line should last for a number of years. However, if you require the white line to be renewed at any time in the future, there will be a charge which is currently also £210.
- **The white line is non-statutory, ie. it has no legal significance.** However, it has been found that there is some degree of voluntary compliance where this line highlights the existence of a vehicle crossover.
- Should you decide that the white line entrance marking is not required after your application has been processed and an officer has made a site visit, a £89 administration charge will be deducted from the refund.

Obstruction of a vehicle crossover is a matter for the Council's Parking Enforcement Team. They may be contacted on 020 3856 0036, 24 hours a day, seven days a week although enforcement will normally only take place between 08.00-21.00. We would ask you to keep the white line clear yourself in order to strengthen its deterrent value.

If you wish us to proceed with the white line entrance marking, please complete the form below and return it to us via email to Crossovers@enfield.gov.uk. Then pay for the white line via either of the following methods:

- Debit/credit card on the Council's website www.enfield.gov.uk quoting the customer reference number X1234567. Please forward the payment confirmation email that you will receive directly following your on-line payment (screenshots are not acceptable) to crossovers@enfield.gov.uk.
- Cheque made payable to 'Enfield Council' and sent to the Crossover Team at the address above. Please write your name, address and the code ES1369 on the back of the cheque.

Once your payment and signed form are received, we will ask our contractor to add the painting of the white line to their next schedule. We aim for the white line to be painted within 8-10 weeks of your payment being received. However, road markings cannot be laid in adverse weather conditions so periods of prolonged bad weather may cause delays in meeting this timescale.
